(a) Reports of officers, directors and committees;


(b) The election of three (3) directors of the cooperative; and





WHO WE ARE

With a service area that encompasses the entire Eastern Shore of Virginia peninsula, Tangier Island, Va., and Smith Island in Somerset County, Md., A&N Electric Cooperative serves over 39,000 connections and operates over 2,500 miles of power line. The cooperative services a variety of residential, commercial and industrial accounts with a large member base of homes, some commercial developments, and agricultural enterprises.

A board of directors, elected by the membership, guides the cooperative. Board members are elected to one of four election districts. Directors serve three-year terms.

Each August, A&N Electric Cooperative holds an annual business meeting. The meeting provides co-op members the opportunity to meet the management of the cooperative, review the annual report and elect directors. Members who do not attend the Annual Meeting may participate in the election process through the return of their proxy ballots.





WHAT IS MEMBERS HELPING MEMBERS?

Members Helping Members Inc. is a community nonprofit 501(c)(3) organization and was established to assist families needing assistance in paying their electric service bills. Thanks to our generous local community, over \$414,000 has been applied to members'

electric bills since 2009. Over 2,400 members are currently contributing over \$3,000 monthly in amounts ranging from under \$1, with our round-up option, to as much as \$10.

The Accomack and Northampton County Departments of Social Services determine qualified candidates for assistance in the program.

A&N Electric Cooperative, in cooperation with Members Helping Members Inc., secures funding through voluntary donations through the cooperative's electric service bills. Members of A&N Electric Cooperative who would like to donate to the program may do so by checking a box on their electric service bills.

The cooperative also matches a funding grant from CoBank to help support the program.





LIGHTING THE WAY ANNUAL REPORT





A&N Electric Cooperative employees have always been committed to our community by supporting local causes.

In 2019, we organized and created an employee nonprofit organization, Lighting the Way. In 2022, we continued our regular monthly Foodbank volunteer work, held two successful American Red Cross blood drives and cleaned our adopted roadways in Tasley through the Virginia Department of Transportation's Adopt-A-Highway program. The group also supported local organizations including the Eastern Shore Public Library Foundation, Accomack and Northampton Social Services Angel Tree programs, Eastern Shore Literacy Council, and more.

Lighting the Way has empowered co-op employees to highlight community needs and organize support for those needs.

Our nonprofit continues to partner with the U.S. Department of Agriculture and project:HOMES to help local co-op members make improvements to their homes, making them safer and more energy efficient.

Since its inception, Lighting the Way also has raised money through internal fundraising.

4 KEY FACTORS That Impact Energy Bills

You pay for the electricity you consume each month, but there are additional factors that impact your energy bills.



Before electricity can be delivered to your home, it must first be generated at a power plant or from a renewable source. The cost of fuels used to generate electricity fluctuates, which is why you see a power or fuel charge on your monthly bill. This monthly charge covers cost fluctuations without having to continually restructure electricity rates.

Service Costs

Your bill includes a monthly service charge, which recovers part of the co-op's ongoing investments in poles, wire, meters, system maintenance and additional costs necessary to provide electric service.

Weather

When temperatures soar or dip, your cooling or heating equipment must run longer and at maximum capacity, which can greatly increase your energy use. Extreme temperatures can also affect electricity market prices. When the need for electricity increases due to extreme heat or cold, the price of power typically rises.

Energy Consumption

This is the amount of electricity you use each month to power your home's cooling/heating system, appliances, lighting, electronics and more. The amount of electricity you consume is measured in kilowatt-hours, or kWh. You have control over how much energy you use, which can ultimately help manage your monthly costs.

Cooperative Returned Capital Credits in July

Eligible A&N Electric Cooperative members should have noticed a capital credits line item on their electric service bill last month.

As a not-for-profit utility company, A&N Electric Cooperative works hard to provide affordable and reliable service. Each year, the cooperative's Board of Directors reviews the financial condition of the cooperative to determine if a retirement of capital credits can be made.

The board voted to approve the return of capital credits at its May board meeting.

A total of \$2.57 million in capital credits was returned to eligible cooperative members last month.

Energy-Efficiency Tip of the Month

Did you know ceiling fans can make a room feel 4 degrees cooler?

To save energy through ceiling fan use, remember to raise your thermostat a few degrees while fans are turned on. Ceiling fans can help improve comfort year-round. In the summer, operate ceiling fans in a counterclockwise direction. Reverse the direction to clockwise during winter months and set fans on a low speed so warm air can circulate from the ceiling to the lower levels of the room.

Remember, ceiling fans cool people, not spaces. Be sure to turn them off when you leave the room.


PCA to Decrease Slightly Beginning Aug. 1

A&N Electric Cooperative's cost for wholesale power decreased for members beginning Aug. 1, 2023. Residential co-op members should notice the power cost adjustment is now \$0.00604/kilowatt-hour. For every 1,000 kilowatt-hours of use, residential members will save \$5.25 (about a 4% reduction) compared to the most recent power cost adjustment on Jan. 1, 2023. While the power cost adjustment decreased, it will remain an overall charge on a co-op member's monthly billing statement.

The power cost adjustment changes periodically to reflect the cooperative's current wholesale power costs, which includes the costs of generating the electricity you use. This is a State Corporation Commissionapproved adjustment and is a direct pass-through of actual costs, plus or minus any over- or under-recovery of electricity supply costs during the previous year.

ELECTRICITY REMAINS A GOOD VALUE

Although inflation has led to increasing costs in many areas of our lives, the cost of powering your home rises slowly when compared to other common goods. Looking at price increases over the last five years, electricity remains a good value.
